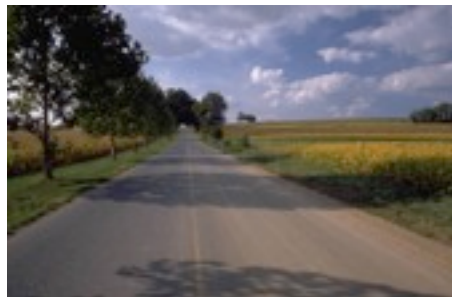
Sarah asked folks to please get your renewals in. Seriously.
